

A LAWYER hanged himself during a probe into an alleged cash swindle, a court heard yesterday.

Ian Walker, 63, took his own

life only seven days after denying involvement in the affair.

Before he died he claimed his

partner, Colin Tucker, 35, was responsible for handling the cash of a senile 79-year-old woman.

But at the High Court in Edinburgh Tucker, who is accused of

a £47,000 embezzlement, has lodged a special defence blaming Walker.

Tucker, now of London, has denied stealing the cash from widow Mrs Jessie McGinty and 90-year-old Miss Doris Duncan. Both offences are alleged to have happened while Tucker was working for Edinburgh law firm Burnett, Walker, of which Ian Walker was senior partner.

Yesterday Law Society chief accountant Leslie Cumming told the court Walker's bank accounts - he had eight totalling almost £700,000 in Edinburgh and London - showed he had been credited with cash from Mrs McGinty's funds.

The trial continues.

## Lawyer's shame in note of death

A SUICIDE note from a lawyer blamed for a cash swindle was read to a jury yesterday.

Ian Walker, 63, hanged himself while Law Society chiefs were probing his firm.

The note which his

wife found in their home at Whitehouse Loan, Edinburgh, said: "I am so, so sorry.

I cannot go on. The humiliation is and will be awful. Forgive me."

## Defence

The note was read at the trial of Walker's partner Colin Tucker at the High Court in Edinburgh.

Tucker, 35, has denied embezzling £47,000 from two elderly women clients. One was 79, the other 90.

Tucker has lodged a special defence blaming Walker.
