It appears that the Trust made a profit of £15,861 on that sale. Is that correct? As the property had not been valued for 3 years, and property prices had increased substantially over that period, this appears to be a modest gain. Can you say why this is so and where the sale was advertised?

What is the value, if any, of Pittencrieff Park in the Trust's balance sheet?


Could you also advise me of the nature of the remaining "Investment heritable property?"


