### 1 Apologies for Absence

### 2 Declarations of interest

Oral

Simon Pepper declared an interest in Cree Valley Woodland Heritage (item 17). He was a Board member for Scottish Natural Heritage who were a project partner and therefore declared an interest. He also noted that SNH was listed as a potential partnership funder for the following applications Enjoy Wild Orkney (item 12), Evanton Wood (item 14) and Saving Our Magnificent Meadows (item 28). He had had no involvement with any of the projects and committee were content that this did not constitute a conflict.

# 3 Chair's Report

Oral

The Chair reported on the HLF related activity and events that she had attended.

Following the December Committee meeting, the recent Board had made the following awards to projects in Scotland:

- Confirmed an increase in grant percentage for Govan Cross Townscape Heritage Initiative scheme
- Awarded grants to Pittencrieff Park, Dunfermline and Haddo Country Park in Aberdeenshire
- An award of £3.940.300 to the Battle of Bannockburn Project
- A first round pass of £4,838,700 including a development grant of £415,000 to the Kelvin Hall project.

The Chair reported that at the February Board there had been much discussion around the new strategic framework and overview of principles and positioning. The Board had endorsed the proposed approach for a strategic framework for the period 2013-19, which was intended to provide confidence to stakeholders about how we would deploy our increased resources whilst retaining the flexibility to respond to emerging needs.

The Chair reported that the Board had an extensive discussion of philanthropy and organisational resilience and had agreed the proposal for start up grants of  $\mathfrak L3-10,000$  for groups taking early steps in developing projects, including the costs required to formally constitute their organisation. The Board had also agreed the proposal for transition funding of  $\mathfrak L10-100,000$  to support organisations undertaking significant strategic change and needing to develop new business models.

The thresholds for the new Repair Grants for Places of Worship scheme had been agreed subject to further discussion with Historic Scotland. HLF would be continuing with key partnerships in the countries. The Board were discussing options for greater flexibility of delegated budgets.

The Board had also agreed the proposals for Landscape Partnerships including raising the upper grant threshold from £2m to £3m from April 2013 and the option to consider an area larger than the maximum stated in the guidelines in exceptional circumstances where the case could be made. The requirement that all programme outcomes must be met would continue but applicants would no longer need to ensure an even balance of delivery across all four areas, responding rather to the needs identified in the landscape character assessment.

There had also been a long discussion around heritage regeneration. The Board remained concerned about how we should address THI-type schemes in the future and asked for further work to be done on the options.

### 6 Development Priorities

CS 2012 (1) 6

Diane Gray recapped on the Committee for Scotland discussion in February.

The Committee noted and agreed the following recommendations for the way forward in the selection of geographic development priorities.

The approach for the selection of priority areas included:

- Geographic area/s that focus on the needs and priorities for our natural heritage
- b) Two urban focused priority areas based on HLF spend, levels of deprivation and opportunity for development
- c) A pilot geographic priority area, working with other lottery distributors, and focusing on development of local skills and capacity.

The Committee supported the methodology for research and information gathering targeting on both the Natural Environment and on urban centres based within a local authority area. Members agreed that links between the natural and built environment should be explored wherever possible.

The Committee agreed the shortlist of areas for the urban focused priority, which were based on per capita spend and on levels of deprivation.

Members noted this was an exploratory list of areas which would be researched further and in conjunction with the third sector.

Colin Mclean, head of HLF Scotland introduced the paper.

Members noted that a new Scottish Museums Strategy was expected shortly and that officers at HLF had contributed in a number of ways to the consultation process.

Surgeons Hall, Edinburgh: Officers had received a first round application from the Royal College of Surgeons of Edinburgh (RCSE) towards the Lister Project for decision by the Board in May. Committee noted the broad outline proposals for this project. A full paper would be circulated to the Committee by e-mail during April at which point the Committee will be asked to vote on a priority.

The Chair, noting that visual material was useful in aiding wider understanding of a scheme requested visual material with case papers in future if appropriate.

Mountain Woodlands Project: The Committee for Scotland had agreed to award a second round grant of £528,900 (21%) to the project in September 2011 on the condition that three planting sites should be confirmed and approved by HLF no later than the end of January 2012, and progress reported back to the Committee's March meeting. Officers confirmed that legal agreements and planting plans had been submitted for three sites.

External environment: Members acknowledged that there was likely to be an increased demand on HLF with reduced available resources for the statutory agencies, for example Historic Scotland and the independent museums. This would undoubtedly impact on HLF and the distribution of funding.

Staffing: Members noted the new staff appointments within the Scotland team.

### 8 Scotland Budget

CS 2012 (1) 8

Lucy Casot, Casework Manager, outlined the Scotland budget for the March 2012 meeting.

The Committee had an available grants budget of £2,615,500 for Heritage Grants. There were seven second round Heritage Grants applications for decision, one of which was a fast track acquisition, and seven first round projects were seeking development funding. The Board had agreed that until the end of the financial year there were sufficient funds across the UK to support all high quality second round applications.

The first round pass budget was £2,590,500 and the value of positive recommendations before committee was £3,069,000. The Committee would need to prioritise the applications before them as there was insufficient budget to support all applications.

# 9 Black Watch Museum: HG-09-06866 DECISION: AWARD GRANT OF £778.000 (31%)

CS 2012 (1) 9

The Black Watch Museum Trust sought a grant towards the redevelopment, extension and redisplay of the Black Watch Museum at B-listed Balhousie Castle. The Museum housed an important collection of over 8,000 items and a highly significant archive.

The Committee for Scotland had approved a first round pass of £750,000 in March 2011 An uplift of £28,000 was requested. Additional project management support had been included as a result of HLF advice.

The Committee for Scotland noted the project strongly met all of the HLF priorities by redeveloping an important museum and its collections and creating a range of opportunities for learning and participation. They agreed the project was a high priority for support and awarded a grant of £778,000 (31% of eligible delivery costs) subject to the provision of a robust Business Plan and Marketing Plan as outlined in the paper.

# **Semple Trail: HG-09-07848**DECISION: AWARD GRANT OF £399,100 (46%)

CS 2012 (1) 10

Renfrewshire Council sought a grant for a project to improve both conservation of and access to a range of important natural and built heritage assets on the former Castle Semple Estate. The Clydemuirshiel Regional Park was of national importance to the heritage and had multiple designations for its natural and built heritage features. The project aimed to enhance access and interpretation to the rich heritage of the site as well as delivering a range of conservation and enhancement works.

The Committee for Scotland had approved a first round pass of £394,800, including a development grant of £34,800 (42% of eligible development costs) in June 2010.

An uplift of £39,100 was sought. Total project costs had increased largely due to capital costs but the grant intervention had decreased from 49%.

The Committee for Scotland agreed this high priority project would deliver a range of heritage and people benefits and awarded a grant of £399,100 (46% of eligible delivery costs).

Members requested the provision of visual material with case papers, where this would improve understanding of the scheme.

# 11 Scotland's Coastal Heritage at Risk Project: HG-10-05032 CS 2012 (1) 11 DECISION: AWARD GRANT OF £307,000 (47%)

The SCAPE Trust sought a grant towards a three-year project which focussed on providing better recording and understanding of Scotland's eroding coastal heritage. The project was split into two key strands, Shore Update and Shore Dig. Both would facilitate skilled and active voluntary custodianship over the country's coastlines, offering real benefits to the heritage, the sector and the volunteers.

The Committee for Scotland had approved a first round pass of £285,200, including a development grant of £5,200 (12% of eligible development costs) in March 2011.

An uplift of £27,000 was sought.

The Committee for Scotland agreed this project was a high priority for support and awarded a grant of £307,000, (47% of total eligible delivery costs).

# 12 Enjoy Wild Orkney: HG-10-03514 CS 2012 (1) 12 DECISION: AWARD GRANT OF £341,100 (42%)

The Royal Society for the Protection of Birds Scotland (RSPB) sought a grant towards a project that aimed to actively encourage people to learn about and experience the diverse natural heritage of Orkney. The project would create an infrastructure to enhance visits to the reserves, improving accessibility and the learning experience. Learning and participation opportunities would help to encourage the local community to become actively involved in the project and to learn a variety of skills.

The Committee for Scotland had approved a first round pass of £351,100, including a development grant of £10,000 (45% of eligible development costs) in March 2011.

The Committee for Scotland agreed the project was a high priority for support and awarded a grant of £341,100, 44% of eligible delivery costs.

# 13 The Renewal of Glasgow Art Club: HG-08-19100 DECISION: AWARD GRANT OF £284,700 (28%)

CS 2012 (1) 13

The Glasgow Art Club Property Company sought a grant towards securing the historic fabric of the A-listed building in central Glasgow and to substantially increase public access by opening up the building and implementing a programme of events.

The Committee for Scotland had awarded a first round pass of £249,900, including development grant of £30,900 (57%) in September 2009.

An uplift of £65,700 on the first round pass was requested. Capital costs had increased significantly with additional structural repairs required.

The Committee for Scotland agreed this project was supportable though recognised the need for the applicant to broaden its approach to linking with other organisations. They awarded a grant of £284,700 (28% of eligible delivery costs).

# 14 Evanton Wood: HG-10-02704

CS 2012 (1) 14

DECISION: AWARD GRANT OF £321,400 (67%)

Evanton Wood Community Company sought a grant towards acquiring Evanton Wood, and implementing a programme of learning activities, access improvements and ecological surveying.

The Committee for Scotland had awarded a first round pass of £283,900, including development grant of £9,000 (78%) in March 2011.

An uplift of £46,500 on the first round pass was requested. Activity costs had increased significantly in line with the requirements of a project of this nature.

The Committee for Scotland agreed the project was a high priority for support and awarded a grant of £321,400, (67% of total eligible delivery costs).

# **De Lucci Tables Acquisition (Fast track): HG-11-06217**DECISION: AWARD GRANT OF £125,000 (34%)

CS 2012 (1) 15

The National Museums of Scotland (NMS) sought a fast-track decision on a grant request to acquire a seventeenth-century Baroque console table. The table was one of a pair which the applicant proposed to purchase in partnership with the Victoria and Albert Museum, London. The tables had originally been purchased by the 5th Duke of Buccleuch in 1833 and furnished Dalkeith Palace until they were sold in 1971 to a private owner. The table that NMS sought would initially *be* displayed in the current European Styles gallery and ultimately in one of eight redeveloped galleries planned in outline to open in July 2015.

The Committee for Scotland noted that acquisition would secure public ownership of an export stopped item. All partnership funding had been secured. An award of £125,000 (34%) was made on condition that the applicant should pursue every opportunity to ensure that the item remained fully accessible.

17 Cree Valley Woodland Heritage: HG-11-03157 CS 2012 (1) 17
DECISION: FIRST ROUND PASS OF £224,600, INCLUDING DEVELOPMENT GRANT
OF £29,600 (91% OF TOTAL ELIGIBLE DEVELOPMENT COSTS)

Simon Pepper left the room before discussion commenced

Cree Valley Community Woodlands Trust (the Trust) sought a first round pass and a development grant towards a project which aimed to improve and enhance woodland in the Cree Valley and to survey archaeological remains. The project would include a number of designated woodland sites and archaeological features. A range of interpretation and activities exploring the ways in which the landscape has been shaped by human activity would be delivered.

The Committee for Scotland noted this well planned project offered a range of potential heritage and people benefits at a relatively modest grant request. A first round pass of £224,600 including a development grant of £29,600 (91% of eligible development costs) was awarded to this high priority project.

18 Old Courthouse Campbeltown 2: HG-11-05230 CS 2012 (1) 18
DECISION: FIRST ROUND PASS OF £472,100, INCLUDING DEVELOPMENT GRANT
OF £44,300 (45% OF TOTAL ELIGIBLE DEVELOPMENT COSTS)

Strathclyde Building Preservation Trust (SBPT) sought first round pass and development grant towards a project that would repair and restore the B-listed complex of buildings at the Old Courthouse in Campbeltown, providing it with a new use as a small business hub. This conservation project would deliver skills training, while a programme of activities would deliver learning benefits relating to the history of this building and which reflected social and architectural change in the west of Scotland over 250 years.

The Committee for Scotland agreed this was a high priority for support and approved a first round pass of £472,100, including development grant of £44,300 (45% of total eligible development costs) subject to the development requirements and conditions of grant set out in the paper.

19 Kelvingrove Bandstand and Amphitheatre: HG-11-03972 CS 2012 (1) 19 DECISION: FIRST ROUND PASS OF £357,200, INCLUDING DEVELOPMENT GRANT OF £57,200 (73% OF TOTAL ELIGIBLE DEVELOPMENT COSTS)

Glasgow Building Preservation Trust (GBPT) sought a first round pass including development funding for a project that would repair and restore Kelvingrove Bandstand and bring it back into use as an outdoor venue. The B-listed Kelvingrove Bandstand was a key feature of the nationally significant Kelvingrove Park in Glasgow. A programme of heritage learning and interpretation activities would be delivered.

The Committee for Scotland agreed this was a high priority for support and approved a first round pass of £357,200, including a development grant of £57,200 (73% of total eligible development costs).

**20** Uncovering the Heritage of the Earth: HG-10-08037 CS 2012 (1) 20 DECISION: FIRST ROUND PASS OF £590,000, INCLUDING DEVELOPMENT GRANT OF £61,500 (76% OF TOTAL ELIGIBLE DEVELOPMENT COSTS)

Dynamic Earth Charitable Trust Ltd (the Trust) sought a first round pass and development funding of £61,500 towards a project which would create a new exhibition within Our Dynamic Earth (ODE). The project would deliver a range of benefits enabling people to learn about the development of the geological understanding of the Earth, focussing on Edinburgh's role in the development of geology as a science.

The Committee for Scotland agreed this was a medium priority for support and approved a first round pass of £590,000, including a development grant of £61,500 (76% of total eligible development costs).

#### 21 Wildlife Counts for Us: HG-11-01200

CS 2012 (1) 21

DECISION: REJECT

The British Trust for Conservation Volunteers (BTCV) Scotland had requested a first round pass of £407,300 including development funding of £13,300 (86% of total eligible development costs), for a project aiming to support communities in Stirling, Falkirk, Lanarkshire, West Lothian and Edinburgh to quantify the biodiversity value of their local urban green-spaces. The project aimed to involve a large group of volunteers in a range of recording activities and to provide four placements in biological recording over a period of three years.

The Committee for Scotland agreed this was a low priority for support and the application was rejected due to the issues raised and the lack of available funding.

#### 22 Ham Girnal Culture Hub for Performing Arts: HG-11-03457

CS 2012 (1) 22

**DECISION: REJECT** 

The Scottish Historic Buildings Trust has applied for a first round pass of £999,900 including a development grant of £252,800 (65% of eligible development costs). The project would repair and restore the B-listed, eighteenth-century Ham Girnal and Corn Mill for use as a performing arts venue. The buildings would then host touring productions, lectures, artists residencies, workshops, summer schools and other music, dance and theatre activities.

The Committee for Scotland agreed that for the reasons discussed the application did not convincingly demonstrate that the project was either viable or sustainable. It was therefore

#### 23 **Braemar Castle Community Heritage Project: HG-11-05273**

CS 2012 (1) 23

DECISION: REJECT

Braemar Community Ltd (BCL) sought a first round pass of £451,200 including a development grant of £55,200 towards the repair of A-listed Braemar Castle project and the provision of enhanced physical and intellectual access, improving the overall visitor experience.

The application failed to meet HLF's strategic priority of improving learning about the heritage, and the lack of a Conservation Statement or Plan represented a potential risk to the heritage asset and to the project costs. Project proposals were under-developed and limited, the project was not well planned.

Members acknowledged the strong community support for the project and the heritage significance of the Castle but agreed the application was not supportable for the reasons discussed. The Committee for Scotland rejected the project.

24 **Prioritisation** Oral

The Committee had rejected Braemar Castle Community Heritage Project and Ham Girnal Culture Hub for Performing Arts.

They had agreed the following priority for the case by case discussions:

- Cree Valley (item 17), Old Courthouse Campbelton 2 (item 18) and Kelvingrove Bandstand and Amphitheatre (item 19) were a high priority
- Uncovering the Heritage of the Earth (item 20) was a medium priority and
- Wildlife Counts for Us (item 21) was a low priority for support.

The Committee considered the portfolio and the available budget. They awarded first round passes to all high and medium priority projects and rejected Wildlife Counts for Us.

Argyll and Bute Council sought a first round pass of £2,735,500 including a development grant of £96,000 (59% of eligible development costs) for a project to restore and provide a sustainable future for Rothesay Pavilion, a key heritage building and community asset at the heart of this town on the island of Bute.

Nine landscape areas have been strategically chosen in Wales, Scotland, Northern Ireland, South West England, South East England and North East England.

### 29 Flodden 500: HG-11-03906

CS 2012 (1) 29

Flodden 1513 Ecomuseum Ltd sought a first round pass of £887,400 including a development grant of £81,700 (82% of eligible development costs) towards delivering this four year project to inform, involve and support the wider Borders community in commemorating the 500th anniversary of the Battle of Flodden which was fought between the Scottish and English on 9 September 1513.

### 30 British Deaf Association's 'Heritage Picture House': HG-11-02534 CS 2012 (1) 30

The British Deaf Association is requesting a first round pass of £785,800 (83%) including development grant of £64,800 (84%) towards a 3 year project to develop an online resource of films, titled the Deaf Heritage Picture House, showing British Sign Language in use since the 1930s along with associated learning resources. The wider project also includes a UK-wide learning and outreach programme including an 'oral history' project targeting older deaf people to help understand what the films reveal about Deaf Culture and British Sign Language over the past 70 years.

**THI Round 14:** THI was a strategically targeted programme with a budget of £14m. Demand had been high with 35 bids requesting a total of £42m. Three applications had been received, for South Side THI (City of Edinburgh Council), Dumfries THI (Dumfries and Galloway Council) and Falkirk THI (Falkirk Council). The Committee were asked to review these bids and assign a priority to each prior to their consideration to the Board in April.

### 33 Falkirk THI: TH-11-02674

CS 2012 (1) 33

Falkirk Council had requested a first round pass of grant of £2,002,000, including a development grant of £50,000 (67% of total eligible development costs) towards a THI scheme to repair and regenerate the historic heart of the town of Falkirk in the Conservation Area surrounding St Modans Old Parish Church. The project would address the poor condition of the main traditional retail streets in Falkirk, and the small wynds which were a particular character of the area.

### 34 English Street THI: Dumfries: TH-11-05278

CS 2012 (1) 34

Dumfries and Galloway Council had requested a first round pass of £881,800, including a development grant of £47,400 (50% of eligible development costs) for a THI in Dumfries town centre. The THI, would focus on English Street and included three building repair projects, two small grants schemes, a public realm project, and a range of community initiatives.

### 35 South Side THI, Edinburgh: TH-11-05131

CS 2012 (1) 35

City of Edinburgh Council (CEC) had applied for a first round pass of £1,191,000 including a development grant of £50,000 (63% of eligible development costs) towards a THI for the South Side area of Edinburgh.

# 1 Apologies for Absence

### 2 Declarations of interest

Oral

Simon Pepper reported that Scottish Natural Heritage were project partner in all three Landscape Partnership schemes (items 44 to 46). He had had no involvement in any of the applications and the Board was the decision taker. Committee were content there was no conflict of interest.

Colin McLean reported that his wife was a Trustee of the Royal Botanic Gardens of Edinburgh (item 32), the applicant organisation for The Botanic Cottage Project (item 32) and that he would leave the room for the discussion of that item.

# 3 Chair's Report

Oral

The Chair reported on the decisions taken by the Board since the last meeting:

The Royal College of Surgeons of Edinburgh had secured a first round pass of £2,853,700 including a development grant of £167,500 for the Lister Project in May. The project aimed to deliver an improved visitor experience, reshaping the way in which the applicant managed its heritage assets to engage with the public.

V&A Dundee: Dundee City Council, were awarded a first round pass of £9,212,500 including development funding of £200,000 towards the creation of a new V&A at Dundee, celebrating Scotland's design heritage and providing a hub for the celebration of international design.

Flodden 500: Flodden 1513 Ecomuseum LTD had received a first round pass of £887,400 including a development grant of £81,700 (82% of eligible development costs) towards delivering a four year project in Scotland and the North East to inform, to commemorate the 500th anniversary of the Battle of Flodden, fought between the Scottish and English on 9 September 1513.

Saving our Magnificent Meadows; Plantlife had received a first round pass of £2,602,100 including a development grant of £1545,900 (62% of eligible development costs) to deliver a three-year cross territory project of activities and conservation works to safeguard lowland species-rich wildflower meadows and grasslands across the UK.

The British Deaf Association received a first round pass of £785,800 (83%) including development grant of £64,800 (84%) towards a 3 year UK-wide project entitled 'Heritage Picture House' to develop an online resource of films, titled the Deaf Heritage Picture House, showing British Sign Language in use since the 1930s along with associated learning resources.

Connections: Science and Art: although the National Museum of Scotland's project had been regarded as a high priority it was rejected in light of the available budget. The applicant had

already resubmitted another application for discussion by the Committee on the June meeting agenda and decision by the Board in July.

The Regeneration of Rothesay Pavilion; this had been another high quality scheme but in the light of the budget available, the Board had rejected the application. Officers anticipated a resubmission.

In a very competitive Townscape Heritage Initiative (THI) batch of applications Falkirk THI had been successful in securing a first round pass of £2,002,000, including a development grant of £50,000 (67% of total eligible development costs). English Street THI: Dumfries and South Side THI, Edinburgh had both been rejected.

<u>Skills for the Future and Training Bursaries Grant Increases:</u> The Board had received a suite of recommendations for grant increases solicited from the Skills of the Future and Training Bursaries grantees. Eight projects would be delivering training outcomes in Scotland. Skills for the Future grant increase applications were awarded to BTCV Scotland, Scottish Wildlife Trust and Museums Galleries Scotland and Training Bursaries grant increase applications to both BTCV Scotland and also Historic Scotland.

<u>Catalyst Endowment applications:</u> Three applications had been submitted from Scotland, The Abbotsford Trust had been successful in securing an award of £1m. Announcements would be made on 20 June at the V&A Museum. Noting that DCMS had contributed £15m for Catalyst endowments, Members queried whether The Scottish Government could be encouraged to match HLF funds in supporting the catalyst initiative.

Members noted there would be a further round of Catalyst small grants offering small capacity building grants available to organisations with little or no fundraising experience. The launch of this programme would be late autumn and Members hoped a wide range of organisations within Scotland would apply.

<u>Townscape Heritage Initiative:</u>The Board had agreed to continue to support the Townscape Heritage Initiative programme with schemes forming part of a major city regeneration but also a new programme which focused on a single historic building or small group of buildings.

<u>Awards:</u> The Riverside Museum had won the European Museum Academy Micheletti Award 2012 and was also a contender for the National Lottery Awards together with Maryhill Burgh Halls. The Scottish National Portrait Gallery won a RIBA award.

<u>Museum and Heritage Awards 2012:</u> HLF had won the top honour at this event. The key theme that ran through all the congratulations received was the helpfulness of HLF and the value of the support and advice offered by the staff.

# 6 Scotland Regional Overview

<u>Strategic Framework:</u> The Fund's new Strategic Framework (SF) is to be formally launched in London on July 5<sup>th</sup>. We do not propose a formal launch as such in Scotland, but to host a meeting

of the Scottish Heritage Forum on July 20<sup>th</sup>, with a slightly extended invitee list, at which we will run through the new Framework.

<u>Grants Budgets and Demand:</u> There had been a substantial increase in the total available budget for decisions in Scotland, from £9.2m in 2011-12, to £13.3m for the current financial year, an increase of 45%. However, Committee were now considering all requests up to £2m, and the ceiling for delegated small grants also doubling to £100,000. Whilst demand for small grants was high, the level of interest for Heritage Grants was more variable.

# 7 Scotland Budget

CS 2012 (2) 7

The annual Scottish budget was £13,346,000 of which £8,180,000 was allocated to Heritage Grants of between £100,000 and up to £2million, £2,583,000 to the delegated grant programmes and £2,583,000 to Repair Grants for Places of Worship.

Members noted the changes to the small grants programmes with increased upper grant limits of £100,000 for Your Heritage and £50,000 for Young Roots, formerly £50,000 and £25,000 respectively.

At the June meeting, the Committee had an available grants budget of £2,045,000 for Heritage Grants. The total value of grants recommended from this budget was £1,755,600 and therefore there were sufficient funds to support all of the applications should the Committee consider they were of sufficient quality. Members noted that just one second round application had been received for decision at the September meeting with a grant request of £455,300.

For first round projects, the budget was £2,454,000 based on a quarterly allocation of the total. Six applications seeking first round passes had been received with requests totalling £3,467,700. Looking ahead to September the total request was 1,712,900. Therefore taking into consideration the demand for both meetings all projects would be supportable within the available budget for the first half of the financial year.

# 8. Repair Grants for Places of Worship

The indicative budget allocation to Places of Worship for 2012-13 was £2,583,000. There were two batches of Places of Worship bids per year, resulting in a budget of £1,291,500 per meeting.

Sixteen applications had been submitted within the current round of the Repair Grants for Places of Worship scheme. One application did not meet the eligibility criteria for the scheme and two applications were for Historic Scotland funding only. Thirteen projects remained for decision by HLF and first round passes totalled £1,516,800. There was also unusually a second round application seeking a small uplift in grant. Second round applications were normally delegated to the Head of Country but as additional grant had been requested, the Committee would need to be the decision taker.

Committee noted there were sufficient funds to support all projects which met HLF criteria well and were considered to be a high and medium priority for support.

# 9 St Bride's Episcopal Church: RP-09-07449 DECISION: AWARD GRANT OF £75,900 (65%)

CS 2012 (2) 9

St Bride's Episcopal Church had requested a second round grant of £75,900, which represented an uplift of £26,900 from the first round delivery request of £49,000. A first round pass of £56,300, including development funding of £7,300 (70%), had been awarded by the Committee for Scotland in March 2011. The original proposal was for a programme of urgent repairs to the roof and high-

level stonework, including replacing inadequate felt roofing and re-pointing stonework damaged due to water ingress.

The Committee awarded a grant of £75,900 (65% of total eligible delivery costs).

# SP3 First round applications for discussion and decision

10 Priestfield Parish Church of Scotland, Marchhall Place: RP-11-07255 CS 2012 (2) 10 DECISION: FIRST ROUND PASS OF £42,600

Priestfield Parish Church sought a first round pass towards repairs to the A-listed Church situated in the Blacket Conservation Area. Works included addressing the dry rot within the exposed timber roof structure of the nave, the north wall and roof area together with subsequent structural repair work, reinstatement of finishes and decorative repair.

Overall the project was regarding as a high priority for funding. The Committee awarded a first round pass of £42,600 subject to the standard second round development requirements.

11 Rosyth Parish Church: RP-11-06831 CS 2012 (2) 11 DECISION: AWARD A FIRST ROUND PASS OF £150,000 INCLUDING DEVELOPMENT FUNDING OF £25,000 (71% OF ELIGIBLE DEVELOPMENT COSTS).

Rosyth Parish Church had requested a first round pass including a development grant of £25,000 (71% of eligible development costs) to carry out works to address the dry rot and repairs to the roof, stonework and rainwater goods.

The Committee agreed that as this project would bring a heritage building back into community use and in general supported officers high priority recommendation and awarded a first round pass of £150,000 including development funding of £25,000 (71% of eligible development costs) subject to the standard second round development requirements.

12 Bothwell Parish Church: RP-11-06916 CS 2012 (2) 12
DECISION: AWARD A FIRST ROUND PASS OF £150,000 INCLUDING DEVELOPMENT FUNDING OF £25,000 (31% OF ELIGIBLE DEVELOPMENT COSTS).

Bothwell Parish Church had requested a first round pass including a development grant towards carrying out roof repairs at the A Listed Church situated in a Conservation Area.

Members agreed that given the high level of heritage and people benefits, the project was a high priority for HLF funding and they awarded a first round pass of £150,000 including development funding of £25,000 (31% of eligible development costs) subject to the standard second round development requirements.

13 St George's Church of S Dumfries: RP-11-07317
DECISION: FIRST ROUND PASS OF £75,000

CS 2012 (2) 13

St George's church had requested a first round pass towards a project based at B-listed St George's Church within a Conservation Area. Works focussed on the repair of high-level masonry, including five urns which had recently been taken down to secure public safety and the supporting parapet wall.

The Committee agreed the project was a high priority for support and awarded a first round pass of £75,000 subject to the standard second round development requirements.

14 Tarbert Parish Church: RP-11-07342 CS 2012 (2) 14
DECISION: FIRST ROUND PASS OF £113,000 INCLUDING DEVELOPMENT GRANT OF
£11,800 (70% OF ELIGIBLE DEVELOPMENT COSTS)

Tarbert Parish Church had requested a first round pass including a development grant towards a project which would ensure that the B-listed church building was wind and water tight through an extensive scheme of repairs including the creation of a 10 year management and maintenance plan and access assessment.

The Committee agreed this was a medium priority for support and awarded a first round pass of £113,000 including a development grant of £11,800 (70% of eligible development costs) subject to the standard second round development requirements.

15 St Mary's and St Peter's Church Montrose: RP-11-05428 CS 2012 (2) 15
DECISION: FIRST ROUND PASS OF £50,200 INCLUDING DEVELOPMENT GRANT OF
£4,200 (62% OF ELIGIBLE DEVELOPMENT COSTS)

St. Mary's and St. Peter's church, Montrose had requested a first round pass including a development grant towards a comprehensive repair project for the church building .The church was an A-listed large cruciform church with tower and stone spire dating to 1858. The building was currently suffering from water ingress through the roofs and walls.

The Committee agreed this was a medium priority for support and awarded a first round pass of £50,200 including a development grant of £4,200 (62% of eligible development costs) subject to the standard second round development requirements.

16 Tomintoul Church of Scotland: RP-11-06643 CS 2012 (2) 16
DECISION: FIRST ROUND PASS OF £88,500 INCLUDING DEVELOPMENT GRANT OF
£10,900 (61% OF ELIGIBLE DEVELOPMENT COSTS)

Tomintoul Church had requested a first round pass of £88,500 (38%) including development funding of £10,900 (61%) towards a programme of roof and masonry repairs at the B-listed Church necessary to make the building structurally sound and water-tight.

The Committee agreed this was a medium priority for support and awarded a first round pass of £88,500 including development funding of £10,900 (61% of eligible development costs) subject to the standard second round development requirements.

17 Hamilton St John's Church: RP-11-06061 CS 2012 (2) 17
DECISION: FIRST ROUND PASS OF £136,800 INCLUDING DEVELOPMENT GRANT OF £25,000 (73% OF ELIGIBLE DEVELOPMENT COSTS)

St John's Church in Hamilton had requested a first round pass and a development grant to deliver a project which would make the B-listed church building wind and water tight through a scheme of repairs.

The Committee agreed this was a medium priority for support and approved a first round pass of £136,800 including a development grant of £25,000 (73% of eligible development costs) subject to the standard second round development requirements.

18 St John's Church, Cupar Fife: RP-11-02682 CS 2012 (2) 18
DECISION: FIRST ROUND PASS OF £150,000 INCLUDING DEVELOPMENT FUNDING
OF £25,000 (71% OF ELIGIBLE DEVELOPMENT COSTS)

Cupar St. John's and Dairsie united parish church had requested a first round pass and a development grant towards repairs at the B listed Church. The proposed works focussed on repairs to the steeple and belfry.

The Committee agreed this was a medium priority and approved a first round pass of £150,000, including development funding of £25,000 (71% of eligible development costs) subject to the standard second round development requirements.

# 19 Thornhill Parish Church: RP-11-07570 CS 2012 (2) 19 DECISION: AWARD FIRST ROUNS PASS OF £120,400 INCUDING DEVELOPMENT GRANT OF £13,800 (75% OF ELIGIBLE DEVELOPMENT COSTS)

Thornhill Parish Church has requested a first round pass including a development grant towards a project that will address the urgent repair needs of the B-listed church building, in particular the roofs and masonry to render the building wind and water tight.

The Committee agreed this was a medium priority for support and approved a first round pass of £120,400, including development funding of £13,800 (75% of eligible development costs) subject to the standard second round development requirements.

# 20 St Patrick's Church, Anderston: RP-11-07349 CS 2012 (2) 20 DECISION: REJECT

St Patrick's church, Anderson sought a first round pass of £150,000 including a development grant of £25,000 (64%) towards a second phase of works which would focus on repairs to the south clerestory façade and upper side aisle roof.

The Committee agreed the low priority application should be rejected due to concerns raised and in light of the available budget.

# 21 St Anthony's Church, Govan, Glasgow: RP-11-07318 CS 2012 (2) 21 DECISION: REJECT

St Anthony's Roman Catholic Church on Govan Road, Glasgow had requested a first round pass of £150,000 including a development grant of £25,000 (60% of eligible development costs) towards the restoration of this B-listed church making it wind and water tight through extensive repairs to the church roof.

The Committee agreed the application was a low priority for support should be rejected on the grounds that this was less strong that others before them and in light of the available budget.

# 22 Holy Trinity and All Saints: RP-11-06829 CS 2012 (2) 22 DECISION: REJECT

The Friends of Holy Trinity and All Saints' Church, North Lanarkshire, have requested a first round pass of £140,300 (49%) including £15,300 development funding to restore a C-listed building making it wind and water tight throughout.

The Committee supported officer recommendation and the application was rejected on the grounds that it was less strong than others before them and in light of the available budget.

## 23 Prioritisation of first round applications Oral

The Committee had awarded a second round grant to St Bride's Episcopal Church (item 9) which included an uplift of £26,900 leaving an available budget of £1,264,600. Committee noted that projects considered to represent a high and medium priority totalled £1,076,500. Committee agreed to support these projects and to reject all low priority projects.

### SP3 Second round Townscape Heritage Initiative application for decision

### 24 Parkhead Cross THI Phase 2: TH-09-05794

CS 2012 (2) 24

DECISION: Award grant of £1,710,300

Glasgow City Council (GCC) sought a grant to deliver Parkhead Cross THI. The scheme included three significant building repair projects and a range of smaller projects, including the restoration of 15 shop fronts and public realm work. Integral to the project was a Community Heritage Initiative which would deliver training, community learning and participation programmes to run alongside the capital works and ensure lasting benefits for the community of Parkhead.

The Committee awarded a grant of £1,710,300 (60% of eligible project costs) subject to the special conditions set out in the paper.

The Committee requested that officers attach a map to their THI project papers in future.

### SP3 Second round Heritage Grants applications for decision

# Opening up the Theatre Royal: HG-11-00488

CS 2012 (2) 25

DECISION: AWARD GRANT OF £850,000 (7%)

Scottish opera (SO) had requested a second round grant towards a project which would redevelop the Theatre Royal providing a new extension and a range of facilities including a new events and education space. A range of innovative heritage learning and outreach activities would encourage new audiences to learn about the history of the theatre and the social history of Glasgow. The Committee had awarded a first round pass of £761,200 including a development grant of £11,800 (94%) in September 2011.

The Committee agreed the project offered a wide range of benefits for people and the improved facilities will help to attract new visitors. They awarded a grant of £850,000 (7% of eligible delivery costs).

# 26 Argyll Mausoleum: HG-09-05966 DECISION: AWARD A GRANT OF £310.000 (30%)

CS 2012 (2) 26

Argyll Mausoleum Ltd had submitted a second round application for a grant to restore, conserve and interpret the A-listed Argyll mausoleum in Kilmun. The project would provide improved accessibility as well as creating opportunities for local people to participate in and learn about their rich local heritage. A first round pass of £203,000 including a development grant of £37,800 had been awarded in March 2010.

The Committee agreed this A-listed Argyll Mausoleum was of high heritage merit and that this was a well-conceived bid offering excellent heritage and community benefits and as such was a high priority for support. They awarded a grant of £310,000 (30% of eligible delivery costs) subject to the further development requirements in the paper and the appointment of a project mentor.

# 27 Seton Fields East: HG-11-06870 DECISION:REJECT

CS 2012 (2) 27

Seton Fields Community Company (SFCC) sought a fast-track decision on a grant request of £430,800 (35% of eligible delivery costs) towards the purchase of Seton Fields East under the Community Right to Buy (CRTB) scheme. The project offered a range of learning and participation opportunities which would enable people to access and understand the site. It would contribute to both national and local strategic aims for biodiversity.

Committee were divided given the strong community engagement which would encourage people to take strong interest in their local heritage, but on balance decided to reject the application due to all the concerns raised and because it was high risk.

### 28 Prioritisation of second round applications

CS 2012 (2) 28

There were sufficient funds to support all second round applications. The Committee had decided on case by case discussion of the applications.

# SP3 First round Heritage Grants applications for decision

29 Canal College: HG-11-04730 CS 2012 (2) 29
DECISION:AWARD FIRST ROUND PASS OF £207,700 INCLUDING DEVELOPMENT
GRANT OF £31,500 (79% OF ELIGIBLE DEVELOPMENT COSTS)

The Waterways Trust Scotland (TWTS) had requested a first round pass including a development grant towards a heritage skills project based on the Union and Forth & Clyde Canals. Canal College focused on the built, natural and cultural heritage of the Forth & Clyde and Union Canals, both Scheduled Monuments. The project sought to address youth unemployment in Falkirk and Edinburgh through a programme of practical projects which responded to the heritage needs of the Union and Forth & Clyde Canals. A number of project activities and outputs would provide learning and participation opportunities for the wider community.

The Committee for Scotland agreed the project which offered potential to delivery good outcomes was a high priority for support and they approved a first round pass of £207,700 including development grant of £31,500 (79% of eligible development costs).

30 The Corn Exchange, Dalkeith: HG-11-03286 CS 2012 (2) 30 DECISION:AWARD FIRST ROUND PASS OF £1,467,400 INCLUDING A DEVELOPMENT GRANT OF £48,800 (59%)

Melville Housing Association (MHA) has requested a first round pass including a development grant towards acquiring and restoring the A listed Corn Exchange building in Dalkeith. MHA would move head office to the site and the remaining 50% floorspace would become fully accessible to the public with exhibition space, interpretation, community meeting rooms and the relocated Dalkeith Museum. A dedicated Heritage Officer would deliver learning and participation opportunities during and on completion of the work.

The Committee agreed this well planned project, which would save and find an end use for a building at risk and deliver a range of people and wider benefits, was a high priority for support. They approved a first round pass of £1,467,400 including a development grant of £48,800 (59%).

31 Scottish Dragon Finder: HG-11-04740 CS 2012 (2) 31 DECISION: AWARD FIRST ROUND PASS OF £383,100 INCLUDING DEVELOPMENT GRANT OF £20,500 (73% OF ELIGIBLE DEVELOPMENT COSTS)

The Froglife Trust sought a first round pass and a development grant for a project that would involve local communities in the conservation of amphibians and reptiles in Scotland. Over a period of 4.5 years, the project would combine opportunities to participate in habitat conservation work and recording activities with organised training sessions and learning opportunities targeted at a wide audience. Three year-long apprenticeships would also be offered.

The Committee considered the project was a high priority and approved a first round pass of £383,100 including a development grant of £20,500 (73% of eligible development costs).

# 32 The Botanic Cottage Project: HG-11-05434 CS 2012 (2) 32 DECISION: AWARD FIRST ROUND PASS OF £701,700 INCLUDING DEVELOPMENT GRANT OF £1,700 (18% OF ELIGIBLE DEVELOPMENT COSTS)

Colin McLean left the room before discussion commenced.

The Royal Botanic Gardens Edinburgh (RBGE) sought a first round pass and development funding towards a project that would rebuild 'Botanic Cottage' - the first gardener's cottage from the original Botanic Garden site, dating to around 1764 relocating it to the Demonstration Garden area in the current Botanic Gardens in Inverleith. The project would also communicate the rich history of the Edinburgh Botanical Gardens and would deliver conservation skills training. The cottage would become a hub for local community groups as well as enabling local people to become actively engaged in learning about horticulture and its heritage. A project coordinator and technician would be appointed.

The Committee agreed the project was a high priority for support and they awarded a first round pass of £701,700 including a development grant of £1,700 (18% of eligible development costs).

# 33 The Old Schoolhouse, Cottown: HG-11-01502 CS 2012 (2) 33 DECISION: REJECT

The National Trust for Scotland (NTS) had requested a first round pass of £449,000 including a development grant of £62,300 (75% of eligible development costs) towards a project to conserve and convert for residential use an A-listed eighteenth century earth building. The project would also deliver training in traditional earth building skills through the construction of two new properties on the footprint of two other ruined properties on the site. A public activities programme involving local school children and property owners would also be delivered.

The Committee, whilst acknowledging the building's heritage merit, considered the project was a low priority for support given the concerns raised and rejected the application.

# 34 Visitor Reception Upgrade- Grampian Transport Museum: CS 2012 (2) 34 HG-11-04484

DECISION: REJECT

The Grampian Transport Museum had requested a first round pass of £273,000 without development funding towards an extension of the main building to house new visitor facilities. The project would replace existing facilities at the museum providing a new reception, cloakrooms, seating, shop, visitor information and a map of the exhibitions. The Museum told the story of land travel, road building and powered transport with a focus on Scotland in general and the north east in particular.

The application failed to demonstrate that it would help people to learn about or participate in the management of the heritage and the proposals did not offer value for money to HLF. The Committee rejected the application on these grounds.

# 35 Prioritisation of first round cases

CS 2012 (2) 35

Colin McLean left the room before the prioritisation of first round cases commenced.

The Committee had rejected Visitor Reception Upgrade- Grampian Transport Museum (item 34). They decided to reject The Old Schoolhouse, Cottown (item 33) which they felt had had too many concerns rendering it a low priority for funding. The Committee approved first round pass to all remaining applications.

The Committee discussed the following applications for decision by the Board. Their views would be reported to the Board.

# 36 Parks for People Overview

CS 2012 (2) 36

Luke Fisher, Senior Grants Officer, presented the paper which provided a brief overview on the current batch of parks for people applications for decision in June.

There were two SP3 second round applications returning from first round decisions approved in 2010 which were funded by HLF in Scotland. In the Countries, first round passes with a value of £8.3m were approved in 2010. Budget was available to support all projects that passed the quality threshold and offered good value for money.

Within the current batch of first round applications, three had been submitted for the countries including one in Wales and two in Scotland.

### 37 Rouken Glen Park: PP-10-01480

CS 2012 (2) 37

East Renfrewshire Council sought a grant of £2,155,700 (67%) towards delivering a project at Rouken Glen Park, designated in the Inventory of Designed Landscapes for its nineteenth century picturesque style. This project included the conservation of this important park offering a significantly enhanced visitor experience. The heritage of the park included a walled garden, archaeology, glen waterfalls and walks, a boating pond, specimen trees, pavilion, estate drives, entrance gates and important habitats for biodiversity. The site was designated as a geological SSSI. A first round pass of £2,009,200 including a development grant of £123,200 (74% of eligible development costs) had been awarded by the Board in December 2010.

### 38 Dock Park: PP-09-07410

CS 2012 (2) 38

Dumfries and Galloway Council (DGC) sought a grant of £991,300 (49%) towards delivering a project which would transform Dock Park through an extensive repair and conservation programme and through a range of activities engaging people. Dock Park was the oldest park in Dumfries and was a linear riverside park opened in 1896. The applicant had received a first round pass of £904,800, including development grant of £47,300 (50% of eligible development costs) in June 2010.

### SP3 first round applications for discussion and prioritisation

### 39 Stornoway - Castle Grounds: PP-11-07473

CS 2012 (2) 39

The Stornoway Trust, in partnership with the Western Isles Council, wished to restore and revitalise the 158 hectares of outstanding parkland surrounding A-listed Lews Castle on the island of Lewis. Lews Castle Grounds were nationally significant, ranked as Outstanding on the Inventory of Designed Landscapes and have SSSI designation. Works included the conservation of the heritage of the park, provision of improved physical and intellectual accessibility, a programme of volunteer activity including an oral history and digital archive project, an outdoor educational resource for schools and the establishment of key posts.

# 40 Dean Castle Country Park: PP-11-04034

CS 2012 (2) 40

East Ayrshire Council had requested a first round pass of £3,056,800 including a development grant of £27,000 (55% of eligible development costs) for the restoration and development of Dean Castle Country Park. The scheme aimed to deliver multiple projects including the restoration of the

heritage feature, redevelopment of the existing visitor centre into a Centre for Educational Excellence, creation of a civic space and the construction of a new build centre for rural life.

# 41 Prioritisation of first round applications

Oral

The Committee agreed the priority of the applications.

# SP3 First round Heritage Grant application for discussion and prioritisation – July Board

### 42 Connections: Science and Art: HG-11-08228

CS 2012 (2) 42

The National Museum of Scotland (NMS) sought a first round pass of £4,850,100 including a development grant of £207,000 (41% of eligible development costs) towards the display and interpretation of its world-class science and design collections through developing eight new galleries which aimed to inspire and inform visitors.

# SP3 First round Landscape Partnership applications - July Board

# 43 Landscape Partnerships Overview

CS 2012 (2) 43

Luke Fisher, Senior Grants Officer provided a brief overview of the Landscape Partnership programme.

Landscape Partnerships were expected to deliver impacts evenly across all four programme outcomes which aimed to:-

- Conserve or restore the built and natural features that create the areas historic landscape character
- Increase community participation in local heritage
- Increase access to and learning about the landscape area and its heritage
- Increase training opportunities in local heritage skills.

Within the current batch, twenty three applications had been received across the UK with a total first round grant request (inclusive of development funding) of £37,848,200 against an available budget of £22m. Three applications had been received in Scotland and Committee were asked to consider the applications providing feedback and assigning a priority to each.

# 44 Nevis Landscape Partnership - A Place of Contrast: LP-11-03453 CS 2012 (2) 44

The Nevis Partnership had requested a first round pass of £1,927,700 including a development grant of £75,800 41% of total eligible development costs). The five year project would take place in a highly significant landscape (89km2) of national and international importance and a landscape which had multiple designations for species, habitats and evidence of human occupation but which attracted large numbers of visitors each year.

# 45 Inner Forth Landscape Initiative: LP-11-07253 CS 2012 (2) 45

RSPB Scotland has applied, on behalf of a partnership, for a first round pass of £1,975,900 including a development grant of £75,900 (40% of eligible development costs) towards a £4m scheme to restore and celebrate the landscape of the Forth Valley in Scotland's central belt.

# 46 Esk River Valleys LP: LP-11-04432

CS 2012 (2

Edinburgh and Lothians Greenspace Trust sought a first round pass of £1,999,000 including a grant of £100,000 (61% of eligible development costs) towards the River Esk Valleys Landscape Partnership Scheme measuring 130km² and located to the south-east of Edinburgh encompassing two rivers from source to sea. The landscape was characterised by distinctive built and industrial heritage which historically connected the rivers to the communities along their course.

# 49 Report on NHMF/HLFBoard Business

CS 2012 (2) 49

Eilish McGuinness, Deputy Director of Operations presented the report.

The Board had approved the latest proof for the Strategic Framework at their meeting in May and prior to it being launched on 5 July. The Board had also discussed programme naming. For the open programmes they agreed:

- Sharing Heritage (£3-£10k)
- Our Heritage (£10-£100K)
- Heritage Grants (£100k+)

They had also agreed that the new programme to achieve sustainable end uses for historic buildings and sites would be called Heritage Enterprise.

<u>VAT changes introduced by the Chancellor:</u> Following the proposal that alterations to protected buildings (listed buildings and scheduled monuments) will no longer be zero-rated for VAT, the Government had announced an additional £30 million a year for the DCMS run Listed Places of Worship grant scheme, which was expected to offset for places of worship the additional financial impact. This has been guaranteed for the remainder of the present parliament.

# 50 Small grants and annual review

CS 2012 (2) 50

Diane Gray, Development Manager introduced the review on small grants which covered the period 1 April 2011 to 31 March 2012. During this period there was considerable demand under the Your Heritage programme, but as in previous years, there were fewer Young Roots applications.

The total budget for small grants during this period was £2,075,800 supporting high quality projects, from different heritage sectors, and distributed across Scotland. The overall success rate was 55%, (90% for Young Roots compared with 52% success rate for Your Heritage) The average value of award was £32,393 for Your Heritage and £21,889 for Young Roots.

Small grants applications were received from all local authority areas, except for East Renfrewshire, Midlothian, Orkney, and Shetland. The largest number of applications received for small grants were for projects about intangible heritage. 70% of applications to the small grants programmes were from community/ voluntary sector organisations. The value of awards to projects within geographic priority areas, or to priority groups (BAME and 15% most deprived), was 29% of the overall spend on small grants.

The 'All Our Stories' programme (grants from £3,000 - £10,000) launched in April this year, provided a new opportunity for officers to highlight HLF support for community heritage projects. This new programme had received a positive response so far, particularly from groups who had not applied to HLF in the past.

The new grant thresholds introduced in April 2012 had had a positive response.

### 1 Declarations of interest

Oral

Eleanor McAllister reported that she was an Advisory Member on the Board of Historic Scotland (HS) and declared an interest in Historic Scotland National Conservation Centre (item 8).

Seona Reid commented that paper for Historic Scotland National Conservation Centre (item 8) made reference to the *Scottish Ten* project. This partnership project was led by HS and its partner the Glasgow School of Art. The Committee agreed this did not constitute a conflict of interest.

Simon Pepper in his capacity as a Board Member for Scottish Natural Heritage (SNH) reported that SNH were providing partnership funding for two applications: *Flow to the Future (item 7)*: and *Loch Leven Heritage Project (item 13)*. He had had no involvement with either application. Committee were content that this did not constitute a conflict of interest.

Willie Macleod noting that RSPB were the applicant for Flow to the Future (item 7) he mentioned his mystery shopper involvement with RSPB reserves. He also reported that New Lanark were a partner in the Scottish Ten project referenced in Historic Scotland National Conservation Centre (item 8). Neither represented a conflict of interest.

# 2 Chair's Report

Oral

The Chair reported there had been an excellent launch of HLF's Strategic Framework for 2013-2018 at the Scottish Government on 6 July. John Leighton, Director-General for the National Galleries Scotland had spoken at the event and had been very complimentary to HLF and its achievements for the heritage sector. Attendance at the event was good and there was particular interest in the new digital policy, the new flexibility on the scale of LPS schemes, and around the new Heritage Enterprise Initiative. There had been a mixed response to the extension of HLF grant making to include the possibility of recipients in the private sector.

There had been good attendance at the Nesta Innovation Lab on 4 July. The aim was to explore innovative ways of delivering public services such as parks by using ingenuity to reduce costs and to find new models of management. The Parks Summit would be held on 25 October at the Royal Geographic Society. This was a major conference on public parks and there would be full representation across all the countries.

The Chair reported that at the Board projects in Scotland had been very successful and congratulated officers. Since the committee had met in June the following applications had been decided at Board:

- Dock Park, received an award of £991,300
- Rouken Glen Park, received an award of £2,155,700

- Stornoway Castle Grounds was awarded a first round pass of £4,099,200 including development grant of £195,600
- Dean Castle Country Park had been rejected
- Nevis Landscape Partnership A place of contrast had received a first round pass of 1,927,700 including a development grant of £75,800
- Inner Forth Landscape Initiative Partnership were awarded a first round pass of £1,975,900 including a development grant of £75,900
- Esk River Valleys Landscape Partnership had been rejected and
- The National Museums Scotland had received a first round pass of £4,850,100 including a development grant of £207,000 for their Connections: Science and Art project.

The Chair briefly mentioned that in October the Board would be discussing the funding programmes including Grants for Places of Worship programme and Townscape Heritage Initiative and its relationship with the new Heritage Enterprise programme and Landscape Partnerships (LP) too.

<u>Project visits:</u> Members reported on visits they had attended including the project which saw the release of the magnificent Sea Eagles.

Officers had approached the Scottish Government who were currently considering whether they could support the catalyst initiative.

### 5 Scotland Regional Overview

CS 2012 (2) 5

Colin McLean, Head of HLF Scotland, introduced the overview.

<u>2014 Commonwealth Games</u>: Scottish Lottery Distributors Forum was proposing a one-off programme to support groups who wished to celebrate the 2014 Commonwealth Games, and officers were currently considering ways of participating with a heritage strand. Other distributors were contributing £1m each to be spread over 2 years. Officers anticipated great demand. The Board in October would be asked to consider a proposal that HLF should participate.

The Committee agreed this was a good opportunity for HLF to collaborate in a small grants (up to £10,000) scheme in Scotland to mark the 2014 Commonwealth Games and other key milestones in Scotland in 2014. They were less keen on the 'Celebrating 2014' title. They recommended that the Board should allocate an additional £1m to the new programme spread across two years.

<u>Significant Projects</u>: Members received an update on potential major grants in Scotland. Abbotsford had opened a new visitor centre in August with high numbers of visitors numbers experienced.

<u>All Our Stories:</u> Small Grants: the initiative launched, with the support of the BBC had attracted much demand. 121 applications had been received in Scotland. The Board would be considering allocating more funds in October due to the high demand and current low success rate for applicants.

<u>Key government departments relevant to HLF:</u> Ed Vaizey, was the new Minister for Culture, Communities and Creative Industries, whose brief now included heritage. Tourism and the lottery

now fell within Hugh Robertson's brief. Maria Miller, was the new Secretary of State for Culture, Media and Sport.

In the Scottish Government, Alex Neil and Nicola Sturgeon had swapped roles, with the latter now Deputy First Minister and Cabinet Secretary for Infrastructure, Investment and Cities. Fiona Hyslop remained Cabinet Secretary for Culture and External Affairs, and Humza Yousaf had been appointed as Minister for External Affairs and International Development, with a portfolio that included: culture and the arts, broadcasting, architecture, built heritage, Historic Scotland and lottery funding.

Cottier Project, HF-01-00044/2: Four Acres Charitable Trust had received a grant in 2003 for the Cottier Project which seeks to restore the A-listed former Dowanhill Parish Church and its internationally important interior and support the sustainability of its use as a theatre. In a Decision between meetings in August the Committee for Scotland agreed that Four Acres Charitable Trust could deliver a reduced scheme at the original level of grant award and specifically 1. Agree further reduction in approved purposes 2. Approve increase in grant percentage from 60% to 62% (of total grant award £1,878,000)

# 6 Scotland Budget

CS 2012 (2) 6

Lucy Casot, Casework Manager outlined the budget for the September meeting.

The Committee had an available grants budget of £2,305,833 for Heritage Grants. The total value of grants recommended from this budget was £777,300. Members noted that six second round applications had been received for decision in December with a combined grant request of £2,935,100.

The available first round budget was £2,352,033 for Heritage Grants. The total value of first round passes recommended from this budget was £1,902,100. The pipeline for first round applications for decision in December was £2,381,800.

Committee noted there were sufficient funds to support all applications at the September meeting which met the quality threshold.

# 7 Flow to the Future - Connecting People and Peatlands: HG-11-06002

RSPB Scotland sought a first round pass of £4,061,800 including development funding of £147,000 (75% of eligible development costs) for a five year landscape scale peatland restoration and engagement project in the Flow Country. The project would restore over seven square miles of peatland which would make a significant contribution to global climate change targets, whilst dramatically improving the habitats for a great number of rare plants and species.

# 8 Historic Scotland National Conservation Centre: HG-12-02542 CS 2012 (2) 8

Eleanor McAllister left the room before discussion commenced.

Historic Scotland sought a first round pass of £3,493,200 including a development grant of £123,000 (50% of eligible development costs) to create a National Conservation Centre in Stirling.

The project would create a centre of excellence in education and training in craft skills, conservation, digital and conservation science.

### 10 Flodden 500: HG-11-03906

Flodden 1513 Ecomuseum Ltd sought a grant of £877,300 towards a four year project to inform, involve and support the wider Borders community in commemorating the 500th anniversary of the Battle of Flodden which was fought between the Scottish and English on 9 September 1513. The project would create strong links between the various sites and communities, creating a sense of place and collective identity as well as enhancing the heritage interpretation and provide a lasting legacy through improved interpretation and better access. The Board had approved a first round pass of £887,400, including development grant of £81,700 (82% of total eligible development costs) in March 2012.

# SP3 Grant increase applications for discussion and decision

Highlanders Museum Grant Increase: HG-09-05010 CS 2012 (2) 11
DECISION: 1. MAINTAIN A GRANT OF £750,000.
INCREASE THE GRANT PERCENTAGE FROM 22% TO 25% OF TOTAL ELIGIBLE DELIVERY COSTS

The Highlanders Museum had requested a change in HLF grant intervention to enable them to deliver their project which aimed to transform the visitor experience at the Museum in Fort George. The Museum's layout and displays would be upgraded providing enhanced interpretation and improved access to the collections and the historic site. Improved storage facilities, conservation works and environmental upgrades would be provided. A grant of £750,000 (22% of eligible deliver costs) had been awarded in March 2011.

On balance the Committee noted that the project offered potential to contribute to the wider area both from an economic and regeneration aspect as well securing a valuable heritage asset and an outstanding military collection. They agreed to 1) maintain a grant of £750,000 and 2) to increase the grant percentage from 22% to 25% of total eligible delivery costs.

12 Fairfield Grant Increase: HG-08-10508 CS 2012 (2) 12
DECISION:AWARD GRANT INCREASE OF £227,000 TO MAKE A TOTAL GRANT OF
£872,000 (21% OF TOTAL DELIVERY COSTS)

Govan Workspace Ltd sought a grant increase towards the conservation and restoration of the A-listed Fairfield Shipyard building currently on the Buildings At Risk Register. The building would be used as a business centre, with flexible space for use by the local community. The project would increase access and encourage involvement in the heritage through the dedicated public spaces, engaging people in new interpretation and providing a range of educational opportunities. Formal learning opportunities in construction skills would be offered. A Community Engagement Officer would be appointed to lead on all activities and there was a strong focus on volunteering to ensure that heritage related activities would be continued beyond the life of the project. The Committee had awarded a grant of £645,000 (15% of total eligible delivery costs) in June 2010.

Members noted that project costs had increased by £376,690 largely due to additional repair and preliminary costs incurred. The grantee had minimised cost increases to the capital works without impacting on the approved purposes of the project. They had secured some additional partnership funding however, there was a shortfall of £227,000.

Members agreed the project to restore a key building in an area of major social and economic deprivation, offered strong heritage and community benefits. With the grant increase, the project still represented good value for money. The Committee for Scotland awarded a grant increase of £227,000, to make a total grant of £872,000 (21% of total delivery costs).

# 13 Loch Leven Heritage Project Phase 3: HG-09-04197 DECISION: AWARD GRANT OF £330,600 (34%)

The Rural Access Committee of Kinross-shire (TRACKS) sought a grant towards the completion of the Loch Leven Heritage Trail in Kinross. The project included the creation of 6.5kms of new trail running from Kinross Mill to the RSPB Vane Farm Reserve on the south side of Loch Leven providing the final link in a heritage trail circuit. The project would introduce new heritage interpretation and provide public access. A first round pass of £241,500 and development grant of £11,500 (46% of eligible development costs) had been awarded in June 2010.

The Committee for Scotland awarded a grant of up to £330,600 (34% of eligible delivery costs).

### SP3 First round Heritage Grants applications for decision

14 Moat Brae - the Birthplace of Peter Pan: HG-11-00065 CS 2012 (2) 14
DECISION: FIRST ROUND PASS OF £1,902,100 INCLUDING DEVELOPMENT GRANT
OF £219,700 (68% OF ELIGIBLE DEVELOPMENT COSTS)

The Peter Pan Moat Brae Trust sought a first round pass including a development grant towards the restoration of a B-listed Georgian villa Moat Brae associated with the author J. M. Barrie. The building and garden was adjacent to Dumfries Academy where the author was a pupil. The invention of Peter Pan was credited to the memory of playing with friends in the garden of the house.

Subject to the various issues raised being addressed, the Committee approved a first round pass of £1,902,100 including a development grant of £219,700 (68% of eligible development costs).

Diane Gray, Development Manager, provided an update on work undertaken to date with the development priorities.

HLF officers have met with local authority representatives in the six geographic areas identified by Committee as possible priorities for the new strategic planning period. Officers had sought to

ascertain potential for partnership working, and willingness of local partners to invest in the development of heritage projects. The findings from these discussions, along with information from desk-based research would be presented to the Committee in December.

Officers reported that Members of the Lottery Distributors Forum had agreed that it was not possible to select a joint pilot area at this time. HLF would continue to collaborate with individual lottery funders as opportunities arose. Officers were continuing to explore the potential of development support for the natural heritage sector, particularly focused on promotion of funding opportunities.

At the Committee's meeting in June, Officers were asked to provide information on HLF funding to projects in Glasgow at ward level. Since 1994 HLF had awarded 240 grants to projects in Glasgow with a total value of £108m. 20 of these awards had been over £1m. In the last ten years, HLF had awarded over £53m to projects in Glasgow with a per capita spend of £89.90. The per capita spend for Scotland for the same period was £55.76.

Members noted the table which set out HLF investment across the twenty one wards in Glasgow. Six out of the twenty-one wards had a per capita spend above the Scotland average. Four wards had a per capita spend of less than £1. These wards faced significant social and economic challenges and Officers hoped that HLF funding programmes for Your Heritage, Young Roots, and the new Sharing Heritage programme could be the starting point to engage with partners in these areas.
