Declarations

Compeared **Alexander Black, Senior**, aged 47 Coalhewer residing in New Forresters Row at the Townhill Colliery within the Burgh of Dunfermline and County of Fife being duly cautioned examined and interrogated.

I declare that I saw a large assemblage of people at the Townhill Colliery on the afternoon of Monday the 24th day of June current between the hours of 3 and 4 o'clock. I went along with the mob but I did not enter any houses at said Colliery or attempt to eject any of the Irish labourers or colliers employed thereat. I heard some persons amongst the mob whom I do not know civilly ask some of the Irishmen employed at the colliery to go away but I did not do so myself nor did I use any threats or intimidation to induce said Irishmen to leave the colliery and the mob made no disturbance and created no alarm among the inhabitants of the village of Townhill. All which is truth. Signed Alex Black.

Compeared **Alexander Black, Junior**, aged 20 Coalhewer residing with his father Alexander Black Senior in the village of Townhill within the Burgh of Dunfermline and County of Fife being duly cautioned examined and interrogated I declare that I went to the Townhill Colliery on Monday the 24th day of June current & saw a mob there in the afternoon of that day. I was with this mob but cannot sat whatever their object. I did not enter any house at the Townhill Colliery that day for the purpose of ejecting Irish colliers or aid and abet said mob in any respect whatever, nor did I injure assault or molest any individual whomsoever that day at or near the Townhill Colliery. All which is truth. Signed Alex Black.

Compeared **Thomas Spowart** aged 30 residing at the Water Row Townhill Colliery within the Burgh of Dunfermline and County of Fife, being duly cautioned examined and interrogated I declare that I saw a large assemblage of people at the Townhill Colliery on the afternoon of Monday the 24th day of June current between the hours of 2 and 3 o'clock but I did not join that assemblage nor aid & abet the persons composing it in any respect whatsoever, and I did not threaten or intimidate any of the Irishmen employed at said colliery with a view to induce them to leave their employment there. All which is truth. Signed Thomas Spowart.

Compeared **James Johnstone** aged 54 residing at the Townhill Colliery within the Burgh of Dunfermline and County of Fife, being duly cautioned examined and interrogated I declare that I saw a large assemblage of people at the Townhill Colliery on the afternoon of Monday the 24th day of June current between the hours of 3 and 4 o'clock. Some of the persons in that crowd of people seemed to me to be weavers from their having aprons tucked around their waist. I did not know what brought these operatives to Townhill Colliery that day and I never heard that it was contemplated amongst the weavers and colliers of this district to eject the Irish employed at the looms and in the collieries from this district. I was with the mob at Townhill Colliery on said day at or near the house of a collier named Thomas Smith, but I dissuaded them from entering his house. I heard some of the mob crying out if Smith was to leave the colliery, and I heard him ask the mob to be allowed to remain for a few days to enable him to get his wages which request the mob granted him on my urging them to do so. After that I left the mob & did not join them again that day. All of which is truth. Signed James Johnston.

Compeared **David Kinghorn** aged 23 journeyman weaver residing with his mother Christina Mackie or Kinghorn a widow in Nethertown Back Street in or near the Burgh of Dunfermline being duly cautioned examined and interrogated I declare that I saw no mob in Dunfermline on Monday the 24th day of June last. I went up to Townhill Colliery that afternoon about 4 o'clock & when on my way thither I saw a good many weavers going in the same direction as I was. On reaching the Townhill Colliery, I found a considerable number assembled, moving backwards and forward, but I did not see any of them eject any Irishmen from their houses at said colliery nor did I assist in doing so myself. I saw Mr. Mungall, the overseer at said colliery who charged me with going into a house where an Irishman lodged which was not true and which I denied. I did not join the mob at the Townhill Colliery or aid and abet them in any respect whatever in the ejection of the Irish. All which is truth. Signed David Kinghorn.

which was not true, and
which I denied. I did not
join the mob at the Town-
hill Colliery or aid and
abet them in any respect
whatever in the opinion
of the Irish. All which
is true.
