Thank you for your enquiry to the court under the Freedom of Information Act on 7 July 2014. It has been passed to me to reply. Your request has not been treated under that Act and I respond accordingly.

Your enquiry relates to an on- going action before the Court of Session, in which you are a party and as a Party litigant you are entitled to access to view all papers lodged into the court case. With regard to your request for a rogatory letter from Turkey to The Scottish Courts from 2003, I am afraid that correspondence is only retained for a maximum of 5 years. I can find no trace of any such letter, in the court process or any files retained in the Offices of Court. I am sorry that I cannot assist with this request.

As well as the rogatory letter, you mention that you want all correspondence between the Turkish Authorities and Scot Courts in connection with the fund in medio. I can confirm that the court is not aware of any correspondence between the two authorities other than what is contained within the case before the court and which I have notified you above that you may inspect at any time.
